The Uganda Police Force and Italian Carabinieri (hereinafter referred to as "the Parties"):

WHEREAS the two Parties are desirous of strengthening their cooperation in the fields of the training and the exchange of best practices related to their institutional services;

CONSIDERING that Italian Carabinieri have wide experience and expertise in the field of public order management and general security;

**AWARE** that the Uganda Police Force is committed to enhancing capacity in public safety and general security;

**RECOGNISING** the need for cooperation between the Parties for their mutual benefit in the identified areas of cooperation;

have agreed as follows:

## ARTICLE 1 OBJECTIVE

This Technical Arrangement establishes a framework of cooperation between the Uganda Police Force and Italian Carabinieri in the respective fields of competence and expertise.

The provisions of this Technical Arrangement will in no way permit the derogation from the obligations provided for in other bilateral or multilateral conventions or Arrangements signed by the parties' Countries.

The Parties agree to pursue, to the best of their ability, mutual cooperation along with the following terms.

#### ARTICLE 2 IMPLEMENTATION OF COOPERATION

In order to implement this Technical Arrangement, the Parties appoint the following Authorities, which are responsible for the fulfillment of the obligations present therein:

for Italian Carabinieri, in his capacity as a police force with military status, having general police duty competence and in permanent charge of the public safety, with special prerogatives conferred by law, this Technical Arrangement will be implemented by the Carabinieri General Headquarters - 2nd Department - Staff - International Cooperation Office;

- exchange of own documentation, publication and scientific material in the field of crowd control, management of demonstrations and public meetings, management of riotous situations in the respect of human rights, general public order management, cybercrime, techniques for lawful interception, techniques for fighting terrorism and other offences related to organized crime, command and control, forensics, new technologies, dog unit training, territorial control, traffic police, equipment, logistics/engineering;
- exchange of experts for initiatives organized by either of the two Parties, including courses, seminars, workshops, ad hoc meetings;
- exchange of experiences specifically in the field of training of police personnel and both sides will assist each other in their building of security capacity;
- establishment of specialized permanent desks at respective Training Institutes, upon request of the two Parties;
- participation in meetings, seminars and research panels concerning crowd control, management of demonstration and public meetings, management of riotous situations in the respect of human rights, general public order management, cybercrime, techniques for lawful interception, techniques for fighting terrorism and other offences related to organized crime, command and control, forensics, new technologies, dog unit training, territorial control, traffic police, equipment, logistics/engineering;
- joint participation in projects funded by national and international counterparts or donors.

## ARTICLE 4 SECURITY OF CLASSIFIED INFORMATION

For the purposes of this Technical Arrangement, information and data to be exchanged will be "non-classified", until the entry into force of a General Security Arrangement between the respective Governments.

#### ARTICLE 6 SETTLEMENT OF DISPUTES

Any dispute related to the interpretation or implementation of this Technical Arrangement will be resolved exclusively through direct consultations and negotiations between the Parties.

#### ARTICLE 7 AMENDMENTS

This Technical Arrangement will be amended at any time with the written consent of the both Parties.

The amendment will enter into effect as specified in article 8 of this Technical Arrangement.

#### ARTICLE 8 ENTRY INTO EFFECT, DURATION AND TERMINATION

This Technical Arrangement will enter into effect on the date of its signature by the designed authorities by the Parties.

This Technical Arrangement will remain in effect until one of the Parties decides, at any time, to terminate it.

Each Party may terminate this Technical Arrangement by written communication to be transmitted to the other Party with a notice of three months.

This Technical Arrangement is applied in full compliance with the sets of rules and the laws in force in their respective Countries as well as the international obligations mutually assumed and those arising from the membership of Italy to the European Union.
