

## **Maureen Brown QPM**

Maureen is a former UK Chief Police Officer who has extensive national and international experience at strategic level. During Maureen's UK career she held strategic command roles with responsibility for policing operations, community partnerships and between 2004/2006 inspecting the effectiveness and efficiency of police forces in England and Wales.

In 2008 Maureen was appointed as a Strategic Police Advisor in the European Union responsible for advising on police reform, strategic planning and international rule of law operations. She has advised strategic Governments/Police leaders and has led review teams looking at international policing, police reform and UK development programmes in a wide range of countries affected by conflict.

From mid-2011-2012 Maureen was the lead UK policing adviser to the new Libya Government and since January 2013 has provided strategic planning guidance to the Ministry of Interior and National Security in Guyana and Somalia and on leadership development in Pakistan and China. Additionally Maureen has international experience in course development, leadership training and providing mentoring support to senior EU and international leaders. She is a member of the UK Gov Security and Justice Senior Cadre, Associate of the Scottish Institute for Policing Research (SIPR) and Senior Advisor to the International Challenges Forum Secretariat (Sweden).

She was awarded the Queen's Police Medal for Distinguished Police Service in 2010.
